## **SECTION 3: Composition / Information on Ingredients:**

Airlaid paper (wood pulp and polymer binder) known as AIRSPUN, with a fragranced wipe cleansing liquid, individually pre-folded. Aqua, Propylene Glycol, Disodium EDTA Cocamiddopropyl betanine, Polysorbate20, Disodium Phosphote, Methylparaben, Propylparaben, 2-bromo-2- Nitropropane-1, 3-Diol, Parfum, Sodium Citrate, Phenoxyethanol, Aloe Barbadensis. pH 6.8 to 7.0

## **SECTION 4: First Aid Measures:**

**Eyes** - Avoid contact with eyes. If contact does occur,

rinse well with warm water.

**Inhalation** - It is unlikely that inhalation will be a route of exposure.

**Ingestion** - If swallowed, the formulation may cause slight irritation to the mouth and upper digestive tract.

## **SECTION 5: Firefighting Measures:**

**<u>Fire Fighting:</u>** If there is a fire close by, use suitable extinguishing agents. The
